You're correct — the 1st U.S. Circuit Court of Appeals reversed a lower court's injunction and allowed the funding cuts to proceed. The lower court had temporarily blocked the Trump-era provision on constitutional grounds (bill of attainder concerns), but the appeals court lifted that block, enabling the administration's policy to take effect.
