Election 2026 — we need the SAVE Act, and we need it NOW.

Our President is doing everything he can to protect our elections, and he is having to fight through a field of snakes all the way.

In February, on Valentine's Day, The Economic Times reported on a Truth Social post on February 13, by Trump, promising to sign an Executive Order requiring proof of citizenship to register and a photo ID to vote.¹ He posted: "There will be Voter ID for the Midterm Elections, whether approved by Congress or not!" [IBID] And "If we can't get it through Congress, there are Legal reasons why this SCAM is not permitted. I will be presenting them shortly, in the form of an Executive Order." [IBID]

He signed the promised Executive Order on March 5, 2026: the Preserving and Protecting the Integrity of American Elections, Order No. 14248.

In 2 U.S.C. 7 and 3 U.S.C. 1, "Federal law establishes a uniform Election Day across the Nation for Federal elections."² Trump intends to enforce the law in the spirit and letter of it. He cites U.S. Court of Appeals ruling in the Fifth Circuit affirmed that Election Statutes set "The day by which ballots must be both cast by voters and received by state officials." [IBID] Several laws, such as the National Voter Registration Act (Public Law 103-31) and the Help

America Vote Act (Public Law 107-252), require States to “maintain an accurate and current Statewide list of every legally registered voter in the State.” [IBID] He cites 8 U.S.C. 1373(c), mandating the maintenance of accurate voter registration lists as a fundamental requirement in protecting voters’ exercise of their “right of consent.”

Trump cites Federal law, 52 U.S.C. 30121, which prohibits foreign nationals from participating in Federal, State, or local elections by making any contributions or expenditures. He points out that, however, this is being circumvented by exploiting loopholes in the law’s interpretation. This is foreign interference in our elections, and it undermines the franchise and the right of American citizens to be governed by persons of their choosing. [IBID]

I can’t read the entire Executive Order, but I’ve linked it in my notes. I read this much to show you something: Trump is laying the groundwork for a lawsuit against any State that violates the law governing Elections. In other words, this EO is not a Presidential Decree about how he wants elections to be conducted — it is a statement of what the Constitution and U.S. Statutes DECREE. As the Executive, this Order sends a clear shot over the bow signaling that he will “fight” for our RIGHT of Consent. He will fight for honest and fair elections for Americans.

The entire Executive Order goes on in this way: documentary proof of United States citizenship, consistent with 52 U.S.C. 20508(b). He cites 52 U.S.C. 21083(a)(5)(A) and uses his office as Executor to stipulate what will be required to comply with the LAW.

He cites U.S.C. code to support:

Documentary Proof of U.S. Citizenship for Federal Voter Registration.

Uniform Election Day Ballot Receipt Deadline.

Federal Agency Coordination on Voter Eligibility. (Proof of citizenship.)

Enforcement of Election Laws

Federal Funding Compliance (enforcement of prohibition against foreign money, and unlawful use of Federal Funds), and

Voting System Standards, protecting against hacking or other manipulation of the machines used by the American people to vote.

Every one of these concerns is tied directly to statutes, forming a legal argument supporting each provision and creating a basis for suing any State, County, or City that violates these provisions.

Read the whole thing, and you'll see what I mean: This is a legal basis for bringing suit against any State, County, or City that fails to execute an election properly, according to our LAWS, and on behalf of the American people.

The Save America Act is intended to enshrine the provisions of this Executive Order, in main, and in pertinent part, into a Legislative Bill that he will sign into LAW.

Not long after these measures were taken, Trump called on the DOJ to secure a warrant to confiscate all election-related material for the 2020 Federal election from Fulton County, Georgia. Here are the

warrant documents, including the allegations and evidence via witness affidavits supporting the warrant.^{3 4 5 6 7}

The warrant requires the delivery of all materials meeting the FBI Affidavit supporting and securing the warrant, and the specific laws that are alleged to have been violated:

§ 20701 — all election materials must be preserved for 22 months. This applies to “all records and papers which come into [the possession of the election officer] relating to any act requisite to voting in such election.”

§ 20511(2) - it is a “crime” to knowingly and willfully deprive” residents of a fair and impartially conducted election process,” specifically, in this §, by the procurement, casting, or tabulation of ballots that are known by the person to be materially false, fictitious, or fraudulent.

ALLEGATIONS:

a. The tabulator machines used by Fulton County are designed to create and save a scanned image of each ballot. Fulton County has admitted that it does not have scanned images of all the 528,777 ballots counted during the Original Count or the

527,925 ballots counted during the Recount.1

b. Fulton County has confirmed that during the Recount of votes, some ballots were scanned multiple times. Ballot images made available in response to public record requests show ballots with unique markings duplicated within the ballot images.

c. During the Risk Limiting Audit, auditors counting the votes by hand reported vote tallies for batches inconsistent with the actual votes within the batch. The State's Performance Review Board² reported that Secretary of State investigators confirmed inaccurate batch tallies from the Risk Limiting Audit.

d. Auditors assisting in the Risk Limiting Audit reported counting purported absentee ballots that had never been creased or folded, as would be required for the ballot to be mailed to the voter and for the ballot to be returned in the sealed envelope requiring the voter's signature for authentication.

e. On the day of the deadline to report the Recount results, Fulton County reported a recount totaling 511,343 ballots, 17,434 ballots fewer than originally counted. The following day, Fulton County then reported a total of 527,925 ballots counted.

I remember Lindell, Powell, and Joseph Rossi gathering the data and building their case. The courts, then, found every excuse possible to bar the case from being heard in open court: their favorite game was to dismiss the case, claiming Americans don't have standing to bring suit against a county they have reason to believe defrauded a national election. They used the same argument against the States that joined Texas, which filed suit for relief against Georgia, Michigan, Pennsylvania, and Wisconsin for fraudulent election practices that effectively stole from the people their right of consent. Joining Texas were Missouri, Arkansas, Louisiana, Mississippi, South Carolina, and Utah. A total of 17 States filed an amicus brief (A friend of the court brief) in support of the Texas suit. But the SCOTUS dismissed on standing grounds.

You see, back then, citizens and States had no standing to bring a complaint against a city, county, or state that, through election fraud, deprived those citizens and States of their “right of consent.”

Well, there is a new Sheriff in DC, and this DOJ is going after Fulton County, Georgia, for allegations of voter fraud.

Here is Joseph Rossi’s testimony, and this looks a lot like an event I remember seeing back in 2021, or 2022? It’s been dragged out of the archives now because of the attention Fulton County is getting over election fraud. You can view it here.⁸ Virtually all of the allegations Rossi mentions have stuck, and the Fulton County election board has never adequately addressed them. The lib-fibbers have hidden behind dismissals to claim the charges have all been debunked. The truth is, the case has never been heard in open court. We hope this will change!

I hope Lindell, Powell, and brave soldiers like Rossi will be fully vindicated.

Here is what “the data shows”:

17,852 votes were counted with zero ballot images to support them.

20, 713 “original” tabulator votes appear out of “thin air.”

3,930 duplicate ballots were inserted into the certified totals.

Now, according to the affidavit filed to obtain a warrant for the confiscation of all 2020 election material kept by Fulton County, after the election officials of that county repeatedly refused to surrender the material requested by the DOJ, requiring the DOJ to send in the FBI to take the records into custody, raising the question, what are they trying to hide? Now, it appears from the affidavit the election board of Fulton County has confirmed several of the suspicions that were raised and denied that Lindell, Powell, and Rossi were trying to get someone to investigate them.

Ballots were mishandled, the chain of custody was botched, and other serious issues have finally been admitted. Together with the witness reports of anomalies that the election board continues to deny, yet refuses to provide the ballots to cooperate with an investigation that seeks to get to the bottom of all this—we expect to discover that Ballots were scanned one day, then random batches were pulled and made into new batches to be scanned again on a different tabulator—double counting the ballots. That's not an administrative error, that's intentional human intervention—that is a criminal act.

In my view, if you find official election personnel involved in any amount of fraudulent activity, that election must be thrown out and done over. PERIOD!

Remember: when Trump said he would decide whether to bomb, bomb Iran “within two weeks.” But it was only a few days later that the B-2s were delivering the “package.” [IBID]

Meanwhile, Trump has amassed a huge military presence on Iran’s doorstep.

The USS Abraham Lincoln carrier strike group has been positioned in the Arabian Sea for almost a month.¹⁰ This includes nine squadrons of aircraft — depending on the type, each squadron can have as many as 24 planes. A fighter squadron of F-16s, for example, will usually have 18-24 aircraft. This strike group has F-35 Lightning IIs and F/A-18 Super Hornets — gnarly. [IBID]

A second strike group, the USS Gerald Ford, fresh from its work in Venezuela, has been en route to join the Abraham Lincoln. It was west of Morocco this past Tuesday. Probably moving through the Strait of Gibraltar today and into the Eastern Mediterranean. [IBID]

A large movement of military planes have been seen moving into the Middle East. Assets are being set up all over the Middle East, Jordan, Saudi Arabia. UK hesitated, but now they are on board. Spain is holding back, but Portugal has stepped up, and we’ve reactivated the base in the Azores. We are building up forces at a string of military bases along Iran's western border: about 4 in Iraq, 3 in Syria, 1 in Jordan, a concentration of 5 in Kuwait, 2 in Bahrain, 1 in Qatar, and 1 in the UAE. We have ships in the Med, in the Arabian Sea, in the Red Sea—I mean, it’s a huge deployment for a negotiation. And the ace in the hole is Israel!

China, Russia, and Iran are wrapping up naval exercises in the Strait of Hormuz and the Gulf of Oman. The Strait was closed for 2 hours to conduct live fire exercises.
