Consent of the Governed is a Biblical doctrine, and an inalienable right of man. But like all rights, it can be subjugated through oppression. Let's talk about the Save America Act.

Ana Paulina wants to attach the Save America Act to the FISA funding Bill.¹¹ That's something, she said, these Senators will crawl over cut glass to pass. She is a fighter! And she knows what battles to choose, what hills to, if necessary, die on — or what battles to make the enemy die on! I like that better!

Did you know that the political doctrine of Consent of the Governed is rooted in the Bible and that it is an intrinsic element of the Gospel? This doctrine places the power of government and, ultimately, the responsibility for its use of power, squarely in the hands of “We, the People.”

These are very serious assertions. For example, did you know that Locke's views on the right of consent and the general acceptance of his views were capitalized on by Paine to rally the Colonists into the Revolutionary War for Independence? I'll save my comments on Paine's painful distortions of Locke's views for my book, *THE CONSENT OF THE GOVERNED—A Divinely Endowed Right of Man: The Bible and the Doctrine of Consent*. But the fact is, Paine's tract, *Common Sense*, radicalized the doctrine of consent, including the fact that while man cannot remove the right from nature, for it is intrinsic in God's Creation of man, he can forfeit his right by exercising his power of “consent,” by consenting to tyranny in trade for whatever the Tyrant offers. One of Paine's more famous quotes is “For as in absolute governments the King is law, so in free

countries the law ought to be King, and there ought to be no other.”¹²

John Locke, who drew directly from Scripture more than any of the others responsible for the articulation of this doctrine, is considered by most to be the first in the “modern age” to lay out a biblical grounding for government. He understood the essential principle that governments derive their just powers from the consent of the governed. It should be understood that Locke was saying this is a universal law intrinsic to God’s creation of man: in other words, this is true without regard to tyrannical rule. The Tyrant has a greater dependency on “consent” than the benevolent ruler who recognizes and submits to the doctrine. That’s why tyrants are so jealous to protect their power against the PEOPLE they rule. The means by which they secure “consent” is torture, fear, intimidation, cruelty, and control of their livelihoods. Whether it is through seduction by bribes, or destruction of the people’s will to resist, the dictator depends upon the willing surrender of the people to his rule, to his domination.

In other words, every dictator depends on “consent.” However, GOD has given consent to mankind, and only those who surrender it in fear or trade it away in covetousness will live under tyranny. Every people who rise and declare: “Give me liberty, or give me death,” will be free. No tyrant can rule a man freed by truth, in whom dwells the Spirit of Liberty. And that, my friend, is the whole reason tyrannical governments cannot allow TRUTH, or

countenance the SPIRIT OF CHRIST. For the truth will make you FREE,¹³ and where the Spirit of the LORD is, there is Liberty.¹⁴

There are many examples of the right of consent to be found in the Bible. One of the most powerful declarations of this principle is found in Jesus' words: "O Jerusalem, Jerusalem, thou that killest the prophets, and stonest them which are sent unto thee, how often would I have gathered thy children together, even as a hen gathereth her chickens under her wings, and ye would not!"¹⁵ He would! But they denied Him their consent: They "would not"!

The Demoncrats hate the Consent Doctrine. They want to destroy it by rigging our elections. They do not want the American people deciding who rules them; they want the Demoncrat Party to decide that. You've watched this in action. Where, you say? You watched it when they pushed Bernie aside for Hillary, and Biden aside for Kamala. They really need to rename their Party the ANTI-DEMOCRATIC PARTY. Actually, they don't care if you vote; they just want to control the outcome. They are content to let the people vote; they just want to control the outcome, and that's why they refuse to enact common-sense laws to protect the integrity of our elections.

for preachers, men of God, to have contempt for speaking the TRUTH of GOD's word to government—or giving direction from the word of GOD to those appointed by Him for the exercise of the powers He ordained, whose officers are by Him called “ministers of GOD.”¹⁸ What sort of arrogance is this, that Christians suppose they can withdraw the LIGHT of God's Word from government and then complain at the darkness prevails. Of course it does. You withdrew the LIGHT.

The Southern Poverty Law Center (SPLC) was indicted on eleven criminal counts.¹⁹ Champion of the left against White Supremacy, the SPLC was sending donors' dollars to the KKK. Why am I not surprised? 2. Named groups include the Ku Klux Klan, United Klans of America, Unite the Right, National Alliance, National Socialist Movement, Aryan Nations-affiliated Sadistic Souls Motorcycle Club, National Socialist Party of America (American Nazi Party), and American Front.

3. The SPLC is accused of using false representations and omissions when soliciting donations—telling donors the money would fight extremism while allegedly using it to pay the very groups it publicly denounced.

4. To conceal the payments, the organization allegedly created fictitious entities and bank accounts, made false statements to banks, and engaged in concealment money laundering.²¹

The SPCL is accused of “manufacturing racism to justify its existence,” and a “massive fraud operation to deceive their donors.” [IBID.]

The SPLC CEO, Bryan Fair, denies all allegations and claims they are “politically motivated.” The SPLC is not politically motivated. Of course, if you ask Maajid Nawaz, a former Islamist who turned liberal Islam reformer and founded the Quilliam Foundation, to counter Muslim extremism, you will hear differently. The SPLC placed this gentle and reasonable organization on its “Hate group list.”²² Right up there with Pro-Life Christians, like the Family Research Council²³ — the SPLC Demoncrat legal bulldog—I call them Bully-Dog—and they raged against Dobson’s organization

because of the audacity of believing what the BIBLE says about homosexuality, the murdering of babies in their mother’s womb—so the SPLC has, from its inception, equated policy opponents as “violent extremists.”
